- Scheduled payments can be deferred if you are enrolled and attending as a regular student in at least a half-time course of study at an eligible institution of higher education **and** properly certified request for deferment is submitted.
- Economic hardship deferment and forbearance are available if you are having financial difficulties. Please contact ECSI or La Sierra University to discuss your eligibility. Proper forms must be submitted for approval.
- When you fail to make a payment or when you file a late deferment, postponement, or cancellation, a late fee of \$1.00 will be assessed on each account for the first month past due and \$2.00 thereafter. Additional fees may also accrue (fee subject to change).
- A processing fee of \$20.00 will be charged for each returned check (fee subject to change).
- La Sierra University reports the account status of all loans to three major credit bureaus on a monthly basis. Negative reports due to delinquency (from late payment or late filing of deferment) will remain on your record for seven years after the account is brought current.
- If your account is sent to a collection agency you will be required to pay all collection and/or legal costs in addition to the full balance of your loan.
- The University may take any action authorized under the Fair Debt Collection Act of 1982 to collect this loan.
- Transcript and/or diploma is withheld if you are delinquent or if your exit interview is not complete.
